The simplest and best way to pay the subscription is to have it deducted direct from the pension paid by the Overseas Pensions Department of the Department for International Development or the Crown Agents Bank (Pension Services). The subscription is then paid direct to OSPA. There is no charge for this service.

The Department for International Development or the Crown Agents Bank require specific authority from the member. To give this authority – once and for all – complete the form below and send it to the OSPA office for onward transmission to the Department for International Development or to the Crown Agents Bank.

This arrangement is the most efficient way of paying subscriptions and is the one that we hope that pensioner members will use wherever possible. Subscriptions are due on 1 January each year (collected in March for pensioners not paid monthly). If payment has not been made for the current year the form should still be completed and sent in, and the subscription due will be deducted at the next convenient payment date.

The subscription rate is £18 for a service or deferred pensioner and £10 for a widow pensioner or eligible wife. The extra postage cost for the magazine sent outside Europe by airmail is £2.
